In respect of the petition filed by Carborundum Universal Limited (CUMI), promoter in 2011, the Company Law Board had passed an interim order on 18 Jan 2011 restricting the Respondents 2-8 from altering the composition of the Board and the shareholding pattern of the Company. The Hon'ble National Company Law Tribunal (NCLT) at the hearing held on 7 Mar 2019 had dismissed the said petitions and has directed SEBI to take appropriate judicious decision as expeditiously as possible on the issue of the purchase of 20% of the public shareholding of Wendt (India) Limited in view of the open offer made by M/s. 3M (Schweiz) AG after providing proper opportunity to CUMI to put forward their views on the issue. The Co. had received a letter dated 26 Sep'19 from JM Financials Limited (JMFL) intimating SEBI's acceptance to the withdrawal of open offer issued by 3M Schweiz in 2011. The Co. had subsequently made a request to SEBI for the letter to ascertain the position. Meanwhile the Co. is in receipt of the SEBI letter to JMFL permitting the withdrawal of the open offer unconditionally only on 5 March 2020. Since then, the Company is in discussions with its promoters on the compliance with the minimum public shareholding.
